  3 <u>An Act To</u> Amend Article 5-a § 103 of the General Municipal Law to allow a chief
  4 engineer the ability to review a state contract bid.

The People of the State of New York, represented in the Senate and Assembly do enact as follows:

8 **Purpose:** This bill will create better communication between contracting officers
9 and the engineer. This communication will allow more accurate cost projections,

- 10 lead to fewer bidding mistakes, and will allow more accurate budgeting for such a
- 11 project in New York State.

## 13 Summary of Provisions

- 14 <u>Section 1:</u>
- 15 <u>Contracting Officer:</u> Any person who, by appointment in accordance with applicable
- regulations, has the authority to enter into and administer contracts and makedeterminations and findings with respect thereto.
- 18 <u>Sealed Bidding:</u> A sealed bid is a document enclosed in a sealed envelope and is
- 19 submitted in response to the invitation to bid. Can only be reviewed by contracting20 officers.
- 21 Engineer and Contracting Officer Bidding: also known as an ECO bid, it is a sealed
- 22 envelope and is submitted in response to the invitation to bid. It is reviewed first by
- 23 the contracting officials, then reviewed by the chief engineer.

## 25 Section 2 m

- 26 1. Except as otherwise expressly provided by an act of the legislature or by a local
- 27 law adopted prior to September first, nineteen hundred fifty-three, all contracts for
- 28 public work involving an expenditure of more than thirty-five thousand dollars and
- all purchase contracts involving an expenditure of more than twenty thousand
- 30 dollars, shall be awarded by the appropriate officer, board or agency of a political
- 31 subdivision or of any district therein including but not limited to a soil conservation
- 32 district to the lowest responsible bidder furnishing the required security after
- 33 advertisement for sealed Engineer and Contracting Officer bids in the manner
- 34 provided by this section, provided, however, that purchase contracts (including
- 35 contracts for service work, but excluding any purchase contracts necessary for the
- 36 completion of a public works contract pursuant to article eight of the labor law) may
- 37 be awarded on the basis of best value. A change to or a renewal of a discretionary
- 38 purchase shall not be permitted if the change or renewal would bring the
- 39 reasonably expected aggregate amount of all purchases of the same commodities,

For purposes of this section, "sealed 43 Engineer and Contracting Officer bids" and "sealed Engineer and Contracting Officer offers", as that term applies to purchase contracts. 44 45 \* 1. Except as otherwise expressly provided by an act of the legislature or by a 46 local law adopted prior to September first, nineteen hundred fifty-three, all 47 48 contracts for public work involving an expenditure of more than thirty-five thousand 49 dollars and all purchase contracts involving an expenditure of more than twenty 50 thousand dollars, shall be awarded by the appropriate officer, board or agency of a political subdivision or of any district therein including but not limited to a soil 51 52 conservation district to the lowest responsible bidder furnishing the required security after advertisement for sealed Engineer and Contracting Officer bids in the 53 54 manner provided by this section, provided, however, that purchase contracts (including contracts for service work, but excluding any purchase contracts 55 necessary for the completion of a public works contract pursuant to article eight of 56 the labor law) may be awarded on the basis of best value 57 5. Upon the adoption of a resolution by a vote of at least three-fifths of all the 58 59 members of the governing body of a political subdivision or district therein stating 60 that, for reasons of efficiency or economy, there is need for standardization, purchase contracts for a particular type or kind of equipment, material, supplies or 61 62 services in excess of the monetary threshold fixed for purchase contracts in this 63 section may be awarded by the appropriate officer, board or agency of such political subdivision or any such district therein, to the lowest responsible bidder or 64 responsible offerer furnishing the required security after advertisement for sealed 65 Engineer and Contracting Officer bids or sealed Engineer and Contracting Officer 66 offers therefore in the manner provided in this section. 67 Justification: Communication is huge factor if Being an engineer. Someone over 68 69 70% of all engineers working for The state of New York are seeking change for the 70 current bidding system, something definitely needs to be done. With the current system in place, A bit request can only be reviewed by one contracting officer, a bid 71 72 request can only be reviewed by one contracting officer. My bill, however, will allow 73 the chief engineer and the contracting officer to look at the bid offer, which can allow a more accurate budget protection, and better chance of finding something 74 wrong within a bill structure. 75
