An Act To: Amend § 114 of the Agriculture and Markets Law to make all animal shelters in New York State "No-Kill" shelters

The People of the State of New York, represented in the Senate and Assembly do enact as follows:

### **Purpose**

10 To mandate all New York state animal shelters to be "no kill shelters".

### **Summary of Provisions**

- 13 <u>Section 1: Definitions</u>
- 14 No Kill: A "no-kill" shelter is an animal shelter that does not kill healthy or treatable
- 15 <u>animals even when the shelter is full, reserving euthanasia for terminally ill animals</u>
- or those considered dangerous to public safety.
- 17 <u>Euthanize: To put (a living being, especially a dog or cat) to death humanely.</u>
- 18 Traditional shelter: An agency which is realistic about the needs of all animals, even
- 19 <u>if it means putting them to sleep due to limited space.</u>
- 20 Section 2
- 21 § 114. Pounds and shelters.
- 22 1. Each town and city, and each village in which licenses are issued shall, and any other village and any county may, establish and maintain a pound or shelter for
- 24 dogs. no kill shelter for dogs and cats.
- 25 2. In lieu of or in addition to, establishing and maintaining such <del>pound or shelter</del>
- 26 <u>no kill shelters</u>, any town or city, or any village in which licenses are issued shall,
- 27 and any other village and any county may, contract for <del>pound or shelter services</del>
- 28 <u>no kill shelters</u> with any other municipality or with any incorporated humane
- 29 society or similar incorporated dog protective association, or shall establish and
  - maintain, jointly or with one or more other municipalities, a pound or shelter. no
- 31 <u>kill shelters.</u>

<u>Justification</u> Kill shelters are a cruel and inhumane environment to these helpless animals who just want to be loved. With New York turning to "no kill shelters", this will increase adoption rates, have healthy and happier animals and turn New York into a more humane state. "No kill shelters" have been credited to greatly reduce the number of animals that are euthanized which will help these poor animals have some justice. If a "no kill shelter" has no room for the animals coming in, it can be transferred quickly to another shelter nearby giving these helpless animals a

- 40 chance to be adopted and live a life they deserve. As animals are being rejected
- 41 and going back onto the streets because of traditional shelters, they are more likely
